**PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE USING THIS SITE**

**1. What is in these terms?**

These terms tell you the rules for using our website <https://digitalfutures.com/> (our site).

**2. Who we are and how to contact us**

2.1 <https://digitalfutures.com/> is a site operated by **Digital Futures Group Limited** ("We"). We are registered in England and Wales under company number 12914233 and have our registered office at 128 City Road, London, EC1V. Our VAT number is 364441891.

**3. By using our site you accept these terms**

3.1 By using our site, you confirm that you accept these terms of use and that you agree to comply with them.

3.2 If you do not agree to these terms, you must not use our site.

3.3 We recommend that you print a copy of these terms for future reference.

**4. There are other terms that may apply to you**

**5. We may make changes to these terms**

We amend these terms from time to time. Every time you wish to use our site, please check these terms to ensure you understand the terms that apply at that time. These terms were most recently updated in April 2023.

**6. We may make changes to our site**

We may update and change our site from time to time to reflect changes to our services, training, our users' needs and our business priorities. We will try to give you reasonable notice of any major changes.

## **7. We may suspend or withdraw our site**

- 7.1 Our site is made available free of charge.
- 7.2 We do not guarantee that our site, or any content on it, will always be available or be uninterrupted. We may suspend or withdraw or restrict the availability of all or any part of our site for business and operational reasons. We will try to give you reasonable notice of any suspension or withdrawal.

## **15. Messages and Data Rates**

- 15.1 Messages and data rates may apply when you opt in to our texting services.

## **16. Our responsibility for loss or damage suffered by you.**

### **16.1 Whether you are an individual or a business user:**

16.1.1 We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors and for fraud or fraudulent misrepresentation.

16.1.2 Different limitations and exclusions of liability will apply to liability arising as a result of the supply of any services to you, which will be set out in our Terms and conditions of supply.

### **16.2 If you are a business user:**

16.2.1 We exclude all implied conditions, warranties, representations or other terms that may apply to our site or any content on it.

16.2.2 We will not be liable to you for any loss or damage, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, even if foreseeable, arising under or in connection with:

We will not be liable for damage that you could have avoided by following our advice to apply an update offered to you free of charge or for damage that was caused by you failing to correctly follow installation instructions or to have in place the minimum system requirements advised by us.

## **17. How we may use your personal information**

## **18. We are not responsible for viruses and you must not introduce them**

- 18.1 We do not guarantee that our site will be secure or free from bugs or viruses.
- 18.2 You are responsible for configuring your information technology, computer programmes and platform to access our site. You should use your own virus protection software.
- 18.3 You must not misuse our site by knowingly introducing viruses, trojans, worms, logic bombs or other material that is malicious or technologically harmful.
